SMART JUMP - Smart entrepreneurial skills for Creative Industries: an inclusive perspective

### **CALL FOR APPLICATION**

This is an open call to partake to Blended Training Activities within the framework of the Erasmus+ Programme. In the context of the Erasmus+ Programme Call for Proposal 2015 — EAC/A04/2014 (EU Regulation no. 1288/2013 of the European Parliament and of the Council of 11<sup>th</sup> of December 2013), it has been approved the project "SMART JUMP – Smart entrepreneurial skills for Creative Industries: an inclusive perspective" (n°2015-1-IT01-KA202-004745 - CUP Code: G76G15000440006).

The above-mentioned project foresees training activities addressed to:

- start-uppers;
- female/young entrepreneurs and SMEs from creative industries and manufacturing sectors;
- practitioners skilled in innovation, creativity and technological transfer;
- VET providers professionals of the SMART JUMP partnership consortium.

### PROJECT OUTLINE

The SMART JUMP project (1st of October 2015 – 1st of April 2018), aims at strengthening the links between training and labour environments, through the improvement of the training offer (with a reduction of gaps of specific skills for entrepreneurship and intrapreneurship) and the support to the governance system referring to education and training. Accordingly, the project intends to enhance the quality of the training offer linked to the entrepreneurship and intrapreneurship of women and young entrepreneurs who are active or have entered the Creative Industries sector. More in detail, by applying the Quadruple Helix model developed in Sweden by WINNET and the Women Resource Center, the project aims at fine-tuning the training offer at local level with the National/regional strategies of development for growth and innovation in Italy, Spain, Hungary and Sweden.

The project envisages achieving the above-mentioned goals through the implementation of Blended Training Activities, combining short-term in-class training with distance learning, in order to enhance transnational skills for creativity and innovation.

The training activity topic is "A TOOLKIT FOR INTEGRATING GENDER EQUALITY IN INNOVATION AS ADDED VALUE in ENTREPRENEURSHIP MANAGEMENT", transferring to participants knowledge and a set of instruments to integrate Gender Equality and Diversity Management in Research and Innovation Systems, promoting in this way a sustainable change in entrepreneurship management and local policies as well.

Learning activities will be structured on the basis of a transnational peer learning approach, through **in-class physical training mobility abroad** and two **distance webinars**.

Main goals of the Training Activities foreseen are:

- supporting innovation with a systematic approach in Creative Industries for financial support of innovation in business development;
- integrating the gender perspective in Creative Industries working routine to strengthen and value their brand internationally;
- setting up a multicultural working environment through a Quadruple Helix partnership (e.g. policy and decision makers, private, researcher and NGOs), with partners and professionals from Italy, Sweden, Spain and Hungary to improve the way creatives enterprises face innovation both on national and international markets;
- developing international networks through innovative and creative methodologies, testimonials from best practices and companies in the Creative Industries sector to support the integration of gender issue in innovation and methods for growth.





















### ART. 1 – BLENDED TRAINING ACTIVITIES ENVISAGED

The SMART JUMP project foresees a Training activity in Sweden at University of Gävle (<a href="http://bit.ly/1tuyXt6">http://bit.ly/1tuyXt6</a>). The Blended Training Activity (SP-VET-BLEND), is structured as follows:

### Total duration $\rightarrow$ 5 days of activity:

- <u>1 day</u> of distance learning on the planned topics, aimed at preparing and homogenizing the group of selected participants;
- 3 days of in-class activity at University of Gävle premises;
- <u>1 day</u> of distance learning, designed to gather feedbacks from participants on the activities carried out and subsequent follow up.

- a. intending to develop business opportunities in the Creative Industries sector;
- b. who have already launched a business or a start up in the Creative Industries sector;
- c. entrepreneurs active in the Creative Industries, manufacturing companies and SMEs, who need a reinforcement on Gender and Diversity management linked to innovation;
- d. policy and decision-makers, with an institutional role in supporting innovation and business development;
- e. other NGOs: actors and researchers with interest in combing innovative theory and practices for development of innovative methods in VET.

### 2. VET STAFF:

Internal staff of Confindustria Veneto SIAV S.p.A. and Fondazione CUOA.

### THE NUMBER OF PLACES AVAILABLE IS 8:

- 4 for VET LEARNERS
- 4 for VET STAFF

EACH PARTICIPANT MUST HAVE AN ENGLISH COMMON EUROPEAN FRAMEWORK OF REFERENCE FOR LANGUAGES  $(CEFR)^1$  LEVEL OF <u>B1 OR SUPERIOR</u>.

Valid Applications will be evaluated by Confindustria Veneto SIAV S.p.A. and Fondazione CUOA on the basis of the compulsory documentation attached to the Participation Form. Hereafter the evaluation criteria applied:

Coherence of the professional profile with the training contents foreseen on the basis of the CV Europass submitted (see art. 3)	max.15 point
English Common European Framework of Reference for Languages (CEFR) level of B1 or superior	At least B1

In case of a large number of application, candidates under the age of 35 will be privileged.

The publication of the final evaluation results will be published online on the website of Confindustria Veneto SIAV S.p.A. and the project website  $\underline{www.smartjump.eu}$  no later than the  $5^{th}$  of August 2017.

Moreover, Candidates not confirming their attendance to the Blended Training Activity or failing to send the above-mentioned withdrawal notice will be considered to have withdrawn in any case.

In case of withdrawal by candidates, their places could be reassigned to the following Candidate included in the Reserve List (if any).

Candidates concerned will receive an email offering them a place. They must accept within 3 working days following the same procedure as above.
